My last email was replied to by telephone and Officer Harvey advised that the police would not be interested in being present for a meeting with my mother or helping with contact information so that I could proceed by email. Later I followed up with a call to an Officer whose name I did not get. She was very attentive and I covered a lot of ground concerning the stalking over the last 15 years and apparent eavesdropping. I would like to know who I spoke with and I would like someone to elaborate about contacting the circuit court on stalking. I've just looked at their website and it's daunting. Is stalking civil or criminal? Do the courts accept emails and respond in writing? My hacked FaceBook account is really a critical piece of evidence. Originally, I had friended Leticia Padilla but someone got into my account and replaced her with my mother. I didn't use the account after that and have had an alias for years since. Now, it shows that I have 6 friends but only one of them is someone I know (Rainy Simone). I've included the link here despite the fact that I've been told you don't accept social media because it's not just something someone said - this is evidence of identity theft. It shows police and protesters in video during June of 2020 in Eureka, California and I wasn't there. Is it possible whoever took those videos is also wanted in my name? A month earlier it shows a dance I wasn't at. If the Eureka Police open a case with this and if Leticia is living here, then will it be considered evidence? The Spring of 2020 is when I believe I saw my mother with Leticia at one of the drug houses on this property, Space #65. Then, I believe she was in Mexico with Leticia in January of 2021. I don't know if there was any followup from last night's call but I've been home all day and didn't hear from anyone. I was going to call because I mostly just want clarification on how to proceed with the courts, but I decided to email because I think my Facebook page should not be dismissed as a cause for questioning.

A reply by phone is fine from whoever is familiar with the situation here. It does not have to be tonight, but at your convenience. It looks as though I may have to find a lawyer, after all. I've asked multiple authorities repeatedly for information that I have a right to, but I've only been given the runaround. Leticia had a friend who was a State Representative in California, is hooked up with an Officer here, and State workers... but I don't know what her professional role is, or why I am given no privacy and no respect while the other people she's connected to are drug dealers and thieves. And there is no way she is able to know where I'm going to be without talking to me unless I'm being spied on. It's not reasonable to be subject to such a negative attack on my character for so many years and be deprived of communication. The only thing I have ever asked Leticia for is a conversation, and that I'm being denied. I've lost a lot of sleep over this. Anyone with a conflict of interest must understand this is very personal. I credit the Corvallis Police for always being very nice to me, however, and I still hope for a quick resolve.
