I would like a reply this email, though I have not received replies to any of my other emails. Last night I woke up to the sound of traffic and I turned on the scanner just in time to hear there was a stolen phone on 9th and the police were looking for the guy. A little while later, an officer requested a different case number related to that incident and Space #65 at Highland View, just down the street from my place. This is one of the drug houses where I saw my mother visit with Leticia Padilla at the onset of Covid, though she's a complete tea totaller and born again Christian who should have no business at a drug house. Despite the fact that we've been estranged for some valid reasons and some misunderstandings, there have been several instances where I have been stalked and I still maintain that there must be some kind of identity theft or fraud involved in this situation. I also still think there are major violations of privacy where I live and that the stalking could not be possible without electronic eavesdropping and the knowledge and consent of my landlord - who I am also accusing of being complicit with the drug trade here, even offering aid.

More than a week ago I contacted you about whether or not my mother was still alive as part of the mission I've been on for a long time to get some answers, but both my emails and my calls were refused. OSP only referred me to records, but it's somewhat understandable since the letter I sent attempted to fit in way too much unnecessary background. At the time, I didn't know if the house I grew up in had burned in the Archie fire, either, and I didn't know who to contact. The Douglas County Sheriff, however, treated me with the utmost of respect and had no qualms doing a welfare check. On the next day's follow up call, I was assured that my mother was doing well and that she would call me. I requested that law enforcement be present for a meeting, or that things be done legally in writing since I believe she must have information that will lead to the arrest and conviction of somebody, though I only have suspicion of identity theft and you won't accept my hacked social media that implicates Leticia as either the perpetrator or another victim, but I doubt they contacted her again.

In the last week, there has been more of a master manipulator dynamic than usual and I am honestly tired of all the attempts to control me. I have not been officially contacted by anyone yet, but the games continue. It is apparent that Leticia doesn't want to meet with me one on one, though she has made time for many of my neighbors, for many years. Still, I am owed some explanations. As I've covered in other letters, I think there has been property, money, and family involved - but I've been excluded, and it's my personal life that's been exploited.

For reasons of accountability, I am writing this to request contact information for both Leticia and my mother. Although I have a physical address for my mom, I don't have an email address and I'm not thrilled about going through a lawyer, a notarized letter, and certified mail. As for Leticia, I don't know if she's the person who considers herself my psychologist but I have a strong suspicion that she lives here since she's stalked me so much, while I have only two possible professional addresses in California, both very old. I think this can all be done by email, anyway. Feel free to pass along my address and this email to either party. They both should know I don't live at Space #65, either. I will follow up on this by telephone tomorrow.
