Forgive me for my procrastination. I have intended to write since Thanksgiving and would like to wish you happy holidays along with a brief update on the property.

As part of the season of giving, I decided to forgive Ivan for the month's rent I believe he rightfully owes... we were given a thousand dollars out of the blue which equaled my investment, and as well the property assessed three thousand dollars higher this year with the only improvement being my landscaping. I didn't tell Ivan because I was afraid it would be like pouring heaping coals upon his head and, well, you know he's got a temper... he doesn't want to acknowledge that I exist, anyway. I would appreciate it if he not poison everything trying to get the tax value down, though. I belive some of my plants were killed this way last year. Otherwise, the damage is done removing the fireplace and chimney from the clubhouse, turning it into a private apartment, removing included services and cutting all the trees he can. I want the property value to go up and I hope to contribute to that. I even thought about fertilizing the whole block so all the lawns would be green, but there were some trespassing issues with that idea and I didn't think Highland View would match me on the other blocks. So, no news is good news.

There has been no change with the property next door. We rarely see our neighbor and he doesn't do anything to maintain his yard. There have been no raids or overdoses, at any rate, and only a few visits to the park by police, not for anything dramatic. He knows I think of him as a wolf in sheep's clothing. I just want him to do his job which is to improve the property and provide security. He does neither. Whatever the case is for the future, it's my intention to recoup my investments before I depart and I don't want to see my home depressed to a low value just so it's easier to resell. And security is as important as aesthetics. I am in touch with Barbara daily and will let you know if anything changes.
