Mr. Huarte,

I have told you many times I will not be signing a new contract with you and you have no legal right to require it. Please stop harassing me about this. The laws in Chapter 90 are more than sufficient - if your manager had any respect for the law. I have asked you to report to me what chemicals are in use on the property, how they are administered and in what quantities - I have every reason to believe that Ivan is dumping industrial bleach in the water pumps and that this is the cause of my health problems and several deaths in the park, including Barbara's.
