Thank you for your reply. I will forego filing in Small Claims for the remainder of this week while you get things straightened out. Although, I am not just requesting a breakdown of my water bill - I am requesting an internet address where the facility water bills should be posted for anyone to see, as per the law I cited. I think you're level of literacy exceeds mine and I'm sure you understood that. Post all the bills you get from the City online for as far back as you can and continuing into the future. If this request is not satisfied, I will continue my Small Claims filing next Monday, September 18th. Your email came while I was getting my collection of emails together for the court - this particular law I advised you about more than a month ago, and my pleas to audit the water have gone on for years. Now the law actually says the manager isn't responsible for the accuracy of the meters, nevermind the fact that he never respected the law, anyway. My average bill has now doubled and it goes exponentially high if I put a sprinkler in the yard. And today, the water smells strongly of bleach, again. Ivan has told me he does this - you may be ill informed - there are chemicals in use on the property, as well as in the water, and I want a full breakdown of that. I've requested this many, many times.

As for legal help, you told me you have legal council already, but it's a moot point because apparently lawyers aren't allowed in Small Claims. My bigger claims are against the Jehovah's Witnesses who have involved themselves in my private life and I believe there is demonstrable evidence of that. There is also more than enough evidence that he enables drug addicts and thieves for personal power, and targets anyone who challenges his authoritarianism. There are ongoing violations of privacy and your manager does not respect my personal boundaries. He has even said, 'So, sue me' while standing in my yard and yelling at me that he IS the Law. And he has intentionally deprived me of things my family wanted for me, and things I wanted for myself. I do not know why he has singled me out, but he is the one who declared the problem with me is personal. And it is very, very personal. I don't think you understand how much he has taken from me. I am tired of the sociopathic totalitarianism, the vindictiveness, and all the gaslighting. This is about my sovereignty in my life and in my home. I am trying to deal with the water and billing separately.

This has gone on for way too long. As I've stated before, and I think is obvious from so many letters, I would rather solve problems through honest, open communication rather than lawsuits or some other solution. I have been villainized by Ivan and his family while they refuse to answer valid questions, even those the law requires. Are you aware he's actually tried to frame me for crimes he knows I didn't commit? And when I see how beautiful the other trailer parks are with all their flowers, it's clear the impact your manager has had on this property. This park is rundown and looks barely maintained. Almost nobody has pressure washed or painted in the last few years, and one by one the lawns and the trees disappear. I have asked what the plan is for upgrading the infrastructure, in particular the pipes... please, let me know! And how I have been treated the last two years since Barbara died has been worse than ever before, full of slander and blame. I still think it's in your best interest, and for all the

rest of us, if you get a better manager. Legal disclaimers and more stall tactics will not solve anything.

I have a request to my water meter reading company to compile a breakdown of your water bills. It will likely come in a PDF format. Give me a week to get all the data from my provider.

We do not put any chemicals in the water. We get the water from the City of Corvallis Municipal Water District, please contact them with your questions as to how water is treated in the city.

My employees have not involved themselves in your personal life.

If you retain legal council I will have to do the same. The freedom with which we communicate will have to end per the advice of lawyers.

I will get you the breakdown of your water bills as soon as I get them. I am requesting January 2023 till the latest one.

> As I'm sure you must be aware, I have not received a reply to my letter of intent dated August 8th. This is a courtesy reminder. You are in violation of ORS 90.582 for which I believe I am entitled to one month's rent. As a result of further harassment on and off the property that your manager is responsible for, I'm tempted to file for the entire \$10,000 allowed in Small Claims. I think I have a case against the Jehovah's Witnesses worth millions and you have accepted some liability. However, this case is specifically about the water. Unless I get a reply with the information I requested - an internet address for the facility water bills, the detailed use of chemicals on the property, and the plan for upgrading the plumbing and the rest of the infrastructure - I will file digitally first thing tomorrow after I put out my trash, which I also have not received a reply about.

> Obviously, this is notwithstanding further legal action as I maintain that your manager and his family have involved themselves in my private life, intentionally depriving me of property and money. Nevermind the slander, framing me for crimes I didn't commit, the fact that he wants me to give up my worldly possessions, and that he doesn't respect my privacy, my dreams, or the dreams of my family.. it is not his job to undermine my authority in life, and I will be treated with respect in my home. Please direct management to be forthcoming with the information I have requested, in writing, or be prepared to forfeit one month's rent plus court fees. I have been patient enough.
