Kim Erdman,

This is a letter to Highland View, though I am writing specifically to you at the request of MIchel Huarte who was acting as liaison for your husband who has refused to communicate with me for many years except to ask for money. For that reason, and because I have accused your husband, Ivan, of directing illegal activities against me, I am also sending a copy to both Mr. Huarte and the Corvallis Police. Any of you may share this letter freely, though I am expecting a reply from you unless Mr. Huarte's attorney would rather reply. I am writing to ask several questions that you have a legal obligation to answer. I have not been able to obtain an attorney myself, but I intend to file in civil court on the week of September 11th if I have not received your answers in writing by then. I will ask for a minimum of one month's rent in damages plus court fees, since that is what the law affords for many of the violations I'm citing, but this is notwithstanding further legal action or criminal charges and would not constitute a final settlement. Honestly, I would rather conduct business by email than go to court, but if you require a court order to be forthcoming with information, then it's only fair I be compensated for the unnecessary expenditure of time and energy to obtain that. I don't think it matters if you believe I deserve to be treated with respect - the law requires it.

The first question is probably the most benign. Today is Tuesday which has been the day for trash collection for a decade and a half. But, yesterday I noticed the majority of the trash was being picked up and I wonder if you are now collecting on Mondays. As you are aware, I don't read the newsletter posted on the office door because it does not constitute a legal notice and I don't feel obligated to come to the office to find out what I can do for you (or how much you want me to pay for something). In my opinion, you work for the residents here and it's not my job to serve you though I've made every attempt to be cooperative with management while maintaining my sovereignty and authority over my personal life. This requires communication. I bring this up because your father is usually the one who picks up the trash and it seems like he's making a special trip when I put my trash out around 8:30 or 9. I have had minimal interaction with your father over the years because while I have always spoken to him with respect, at times he's been extremely rude to me and my guests. I suspect it's just the early onset of senility because at other times he's been very nice, but he may need to be told that the law requires him to treat everyone here with respect even if he doesn't think they deserve it. I don't think of him as an authority here, nor your son, but they have both ridiculed me in the past and they do represent Highland View. You could also unlock the dumpsters and allow me to take my own trash down whenever I want, but whatever. For now, I will continue to put my trash out on Tuesdays unless I am otherwise informed in writing. The reason we have an in writing relationship is that both your husband and Mr. Huarte have lied through their teeth to me for money. I've kept records since, and sending me an email is not too much to ask.

Regarding the water, I would like the link to the facility water bills. According to ORS 90.582, the water bills need to be made accessible on an internet location. It is also stated that I have a right to a meeting to inspect the last year of billing, though I was not offered that when I specifically asked for the last year to be audited. This is a moot point, anyway, since the law now says management isn't responsible for the accuracy of the submeters and Ivan is likely to complain that I've harassed him if I'm ever in the office. Still, I'd like to know what's going on. The submeters that were installed ten years ago are actually twenty years old and built with technology that's at least a decade older than that. They run on single cell lithium batteries that aren't likely to last much more than a decade. And the units aren't even waterproof, they're splash resistant - they're designed to be installed in a closet. After this period of time, it's highly unlikely all the submeters are working. And the accuracy, if that's to blame, sure looks like fraud. One month I was charged for 12,000 gallons of water. That's an average of 400 gallons a day, picture 8x 50 gallon barrels every day, and there's just no way I used that much. I have never seen major increases from taking multiple baths and extra showers on some cold months, aquarium setups, and large batches of laundry - but a sprinkler in my yard seems to cost me at least \$50, even when it's not used every day and never turned on full blast. I still think it would be better for everyone to simply divide the facility water bills evenly among all the tenants and include it in the rent. I can't imagine the hassle of submetering is worthwhile when the discrepancies between mobile homes are so small. I mean, I'm penalized for keeping a green lawn for the dogs and growing flowers, but my contribution increases the value of everyone's space and that should be considered desirable instead of being deterred. But, whatever. Please give me what information you can. I would also like to know what chemicals are in use on the property, especially about what your husband does to treat the water. I think OSHA mandates that this information be made available. And also, please let me know if there is a plan to replace the pipes. The third part of the information I'm requesting is that I would like to know if you have or have had any involvement with my family. When I asked Ivan, he simply said 'that would be illegal" and then proceeded to say he thought he might have seen someone who looked like my mother bouncing around here, but that he couldn't be bothered to keep track of the tenants. Though I am still estranged from my family, I have seen my mother visiting two known drug houses here on the property and I have inquired about this before. I would also like to know if you or Ivan ever met my father, and this is related to the unanswered questions I've had about the illegal transfer of money and property. At one time, I thought I was the victim of some kind of identity theft or fraud at the hands of the drug addicts and professional thieves in the area. When people started slandering me and you made your son the official 'liaison to the mentally ill', I thought justice would be served as a matter of course, that due process, common sense, and the truth would rule. Now I believe the corruption is not so benign. I think the Jehovah's Witnesses have allowed honesty and, guite frankly, the illustration of God's Lovingkindness to take a back seat to the grab for money and power. Greed and the transient security of power in numbers has justified a lot of deceit that comes from your church, and I don't think the ring of drug producers who live here could continue to be so successful if it weren't for the support of management. Added to that, the militant approach to social engineering borders on criminal and lends itself to a lot of lies. I suspect you personally have taken a child from me, and this is more important than anything. I have asked about this and been summarily ignored. It goes without 2 of saying that I would never raise a child to be a Jehovah's Witness, and I have a legal right to know what's going on.

If your beliefs conflict with your job here, you should quit. Otherwise, you are obligated to treat all the people who live here with respect. This is more than a matter of landlord-tenant law. God-given, inalienable rights are Constitutional, that all men are created equal... equality and fairness are at the core of our law. And in the Bible, 1st John Chapter 4 - this was covered before, but apparently management disagreed. 'God doesn't play favorites' is what Barbara would always say. On the topic of honesty, only deceivers depend on hiding information and exploiting what people know. Truth tellers are all about the dissemination of information and bringing facts to light, all of them, the whole truth and nothing but. I have a very live and let live philosophy, and I am perfectly okay with people who disagree with me. Differences of opinion make for good conversation. But I am not okay with people who try to force their beliefs on me. I hope you accept that while I disagree with the Jehovah's Witnesses vehemently, this is about being treated fairly. I do think your husband, and perhaps yourself, have crossed my personal boundaries with complete disregard. I don't rent a room in your house. I own my home, and not even my privacy is respected. I'm not part of your church or your family, and you have no right to meddle with my private life. And the backbiting is almost as bad as the lieing. Throughout my entire life, the Jehovah's Witnesses have only ever deprived me and I have seen nothing but deception, vindictiveness, and fear mongering in the name of God. That is the epitome of evil. I don't expect you to like me. I don't care if you don't. But if you wish to hang a shingle about being Holy, your family should set a better example showing humility, equanimity, and compassion, instead of rigid totalitarianism.

This has gone on for much too long. In all fairness, please just answer my guestions. I'm not going away, and I'm not going to give up my guest, but I would rather not take you to court to get these answers. I will, however, if not every question is satisfied. I think what I want to know about is clear, but if you would like a bulleted list of direct guestions with guestion marks, just let me know and I will provide that. I'm giving you more than a month to respond for legal reasons. I don't think it should take that much time and I don't expect you to be as long-winded as I, but a month's notice in a legal letter of intent seems fair. Please don't hesitate to ask if you would like any further clarifications about the information I'm seeking. I would like you to offer some explanation about the eavesdropping and the stalking, as well. It has never been made clear if I'm the subject of an investigation or some kind of psychological study, but the violations of privacy are without my consent. Fraud and criminal activities aside, this is about respect. That you believe respect must be earned is just erroneous thinking. I could say you haven't earned my respect either, but to intentionally deprive someone of respect unless they adhere to your rule is simply wrong. An unjust weight is an abomination to the Lord. Please note that I have continued to pay my rent and water, even as I respectfully disagree, even as I myself have been robbed. I have been quoted as saying that if you don't treat me with respect, I will command it. That is what this is about. I look forward to hearing from you soon. Or, I will see you in court.

to take sides instead of putting your manager in his place. I do not know why he targeted me to begin with but he has always said this is personal between us, while I have always just seen him as a religious zealot with a set of pathological beliefs. However, when Barbara died things got very, very personal. Your manager deserves to be fired and I no longer feel the need to shelter you from legal action. It no longer matters if he has acted in his capacity as a property manager, or if he was fulfilling obligations to the church. One minute he's yelling, 'I am the law here!', and the next minute he claims to be a humble servant who just follows orders. Whatever the case, this is my home and he has done what he can to dislodge me. I'm not just going to walk away from my dreams to accommodate someone's extreme ideas or someone else's bottom line. The meddling in my private life is illegal, and I have a legal right to the information I'm seeking. Like you, however, I would prefer this to work out amiably. I still credit you for bringing a level head to the table and being the only one who has consistently treated me with respect. Hopefully, this situation will be resolved soon.

Note to Corvallis Police -

I am sending a copy of this to you since it's a continuation of recent emails to your department. I insisted on a response from the police with many of the same requests contained in this email, but I have been ignored. Instead, there have been more social manipulations, more bullshit investigation, and still no justice. I have suspected that Ivan Erdman is with DHS or some other federal agency, but my requests for due process and identification have also been ignored. In fact, it has been considered paranoid behavior that I even asked... and yet, it's sort of obvious. I still don't know the status of my landlord, or if it's someone in his family or church who keeps running interference, but I have exhausted myself asking for due process. It occurs to me that since he has refused to identify himself as anything other than a Sunday school teachar and property manager, he has waived his right to any special privileges. I recognize that one officer after another has been relocated after offering to help me, and I don't blame the Corvallis Police for the lack of information I've requested. I am not expecting you to respond to this email, but you are still welcome...
