#### Claim Description, cont.

I am attempting to investigate unusually high water charges that I believe may be fraudulent, and I would like to know what the plan is for replacing the pipes, among other things. I have been a resident here for many vears but neither the manager nor the owner will answer my questions. Although the law now states that management is not responsible for the accuracy of the submetering system, according to Chapter 90.582 it's required that the facility water bills be posted on an internet location. On August 8th, I wrote a letter to the Owner, Michael Huarte, and sent a copy to the Manager, Ivan Erdman, informing them that I would file in Small Claims on the week of September 11th for the amount of a months rent if they continued to ignore my requests... the Owner has tried to get me to settle for a breakdown of my bill alone, and I believe the Manger has tried to cause problems for me on and off the property, but my questions still have not been answered. There appear to have been problems with the meter last December (2022) and besides discrepancies in the amounts, the service fee has gone up from the original \$5 to almost \$35, and if I water my lawn I get charged double. On average, the bills have been about the same for years - except when there's a sprinkler, then they go up exponentially. My average usage is between 1500 to 2000 gallons of water - but when I water my lawn, I get charged at least four times as much - one bill had my usage at 17,900 gallons, which is like 600 gallons a day. Originally, the agreement to install submeters included that I would be able to read my own meter and check it against the bill. That's not possible with the meter at this unit, and the auditing clause in the newest version of Chapter 90 allows me to go to the office for essentially the same spreadsheet file showing me how much I'm being charged, but this is useless as what I'm requesting is to know is how much water Highland View actually gets from the City or Corvallis. There are 5 water mains on this property with a history of leaks, so somewhat of a breakdown is necessary. This is an attempt to force communication which I think I am entitled to. There are several unresolved issues here and a history that goes back 16 years. I see there is a place for attaching documents and I will upload my letter of intent with the most recent replies, but I have just posted all of the related emails going back 2 years and photos of some bills on my website, skvsurfer.media/water-emails - although I believe I may be getting defrauded for a whole lot more, I'm asking for the amount of one month's rent which is \$512 for the unreasonable amount of time and energy I've expended trying to get information that I have a legal right to. Beyond the small amount I'm claiming, I would like the Court to order Highland View to be forthcoming about the status and plans for the infrastructure, including the use of chemicals on the property, if not requiring a full audit.
