Please read and respond to this letter. I realize this request has been continuously ignored but this is a very serious situation that demands the attention of law enforcement.

I have lived on this property for over 16 years and have complained about invasions of privacy for as long as I've been here, specifically eavesdropping by electronic means. The manager here, Ivan Erdman, has sent people who report to him into all three of the places I've lived on multiple occasions and even asked me to call the office and give the driver's license number of any of my guests. He asked for copies of my keys, which I denied, and he has aided people who have broken into my places while I was gone. To this day, things that I say in the privacy of my own home are echoed back to me in public and management has made no attempt to hide this fact. It is as if Ivan does not recognize personal boundaries or legal ones. He has yelled at me, "I am the law!" while standing in my yard, and he's gone so far as to frame me for crimes I didn't commit.

It appears he's tried to frame me for crimes he believes I should be punished for, anyway, based on his religious beliefs. The mobile home he sold me had a bunch of magazines that bordered on child porn, mostly German nudist magazines and old Australian porn left over from the merchant marine who lived there before me... I turned it in to him for the record, though there was nothing overtly illegal that I saw, and the man who had lived there before me was incapable of being a danger to children by the time he left here. And now people who identify themselves as federal agents keep questioning whether I speak German. If I speak about violence, I hear people matching my description called out on the radio and I'm sure you're aware of the sheer number of calls there have been about me. I think I have been accused of murders, rapes, and thefts, too - but I'm a law abiding citizen. I've defended myself against every kind of slander you could imagine. Someone loves to tell people whatever they might believe, and I appear to be the tool for their fear mongering. And Ivan loves to rally others. His modus operandi is plausible deniability. He is notorious for using what people say selectively, like this person asked me to do this or that person was concerned about that, and pointing the finger of blame at others to keep from having to answer for his personal choices. And yet, the favoritism is obvious. He tries to get people to serve him and rewards them accordingly. Some people are given preferential treatment and others are treated with the utmost of disrespect while Ivan claims they've brought it on themselves. He refuses to sign trespass notices or address issues in writing, just as he refused mediation with me which the law requires, but he believes he should have the authority to determine who is allowed on the property - including who is allowed to visit. He literally had people out on the street keeping anyone from coming to my barbecues, ran off the mormons who were offering to help here, and he has a history of going around telling people who's not welcome and who should have the cops called on them if they're seen. He has asked neighbors to call the police on me for anything they can find, but he's also caused such problems that people have actually taken shots at me. The windshield of my last car was shot twice and I've had people intentionally try to cause me to wreck my jeep on a couple of occasions. There has also been lots of harassment, vandalism, and theft, otherwise.

The problems here on the property are not being dealt with. There is a broken down old foot bridge that hasn't been maintained and is now unsafe - it was a sturdy, level, painted bridge when I first came here. There is also unsafe barbed wire needlessly strung along a section of chain link fence on the north border - surely you have a record of this, police begrudgingly came out to make an official report that there was no danger after many, many calls, and Ivan's father-in-law then ridiculed me about it, trying to chase me down on a bike. It still should be removed, as far as I'm concerned, and I would do it myself except that he would retaliate. But besides the invasions of privacy and the general security issues, I've mostly complained about the toxicity of the environment. The regular production of methamphetamines on the property and the accumulation of poisons used time after time are still a concern and I have valid questions about what chemicals are in use on the property that have not been answered.

The biggest concern of all is the water which I believe is treated with industrial bleach and the problem with this is very simple. My understanding is that the old way bleach was made meant it dissipated very quickly so the practice of purging the pipes with a dose of bleach would not stay toxic for long, but now the form of bleach used causes a buildup of chloramines. The pipes leading from the water mains are very old and just need to be replaced. Please understand the affects this has on the body over time and consider this - both of my dogs, a few other animals, my friend Barbara, and other people in this neighborhood have all died exactly the same way, from a shutdown digestive system. My kidneys hurt daily and I may not make it through the Winter without a cane, myself. I don't understand why this has not received any attention. I have proven abnormally high chlorine levels and I have more than a few years of writings to the City and Highland View about this. Apparently, it's cheaper just to put undesirable people here and watch them die, plus they're able to make money on drugs and studies alike. But bringing in residents with preexisting conditions does not condone knowingly subjecting them to a toxic environment in any way, legally or morally.

Plus, I have made numerous complaints about identity theft and fraud. There has been ample PC to question Ivan about his knowledge or involvement with such, and there have been numerous suspicious circumstances involving my family, property, and money. I even kept hearing about a truck, but nobody has explained that. And Mexico? I got left out that Christmas at Costa Sur, and I was 100% available - the guy who came and went with Leticia the same who tried to start a fight with me last Thanksgiving, and I believe they lived here on this property. This is relevant because she took over my mobile home with a guy who's part of Ivan's church and they were even seen at my off-site mailbox. You should have records of that complaint, already. Reasonable suspicions of fraud reach from there to questionable changes of ownership with businesses and land related to me. And now, most recently, I've uncovered absolute proof of fraud by management and he's defrauding everyone here in the park to the tune of \$4,000 Dollars a month or more - and nobody cares!

I have received a judgement in my favor, though unpaid, and the law is very clear about the obligations of management to post facility water bills on the internet, but this has not been done. I've been ignored through what was the loneliest Thanksgiving I can remember after more than 2 years of pursuing justice on the water alone... and the bills keep coming. No answers. After trying to promote what's happening, I can see only one hit on my website - the court tells me they only make judgements and it's my responsibility to collect, but I think this requires law enforcement. There are laws being violated that need to be enforced. Dispatch tells me Ivan will likely be held in contempt of court. But what am I supposed to do, read another page and fill out another form? Before she died, Barbara used to laugh about how my letters were going nowhere. The chemicals I'm complaining about have been linked to Parkinson's, too. I haven't stopped crying about losing her, and I will never forget the harassment Ivan offered. Her death is his fault, though he tried to blame me. On the topic of death, I have not yet been informed about when and how my father died, as I requested. This is very serious. I've only been offered a link to the state records website, but I personally deserve more respect than that. If Leticia is willing to show up at someone else's funeral and try to hint about my father's death, while showing up in Mexico and at known drug houses in this neighborhood - with my mother! - then she can come talk to me directly. For whatever reason, police always offer me clandestine meetings like at the hospital, years ago by the brew tanks at block 15 south, or lurking behind blackberry bushes by the river, but is there anything stopping her from knocking on my door or calling me on the phone like a normal person? I'm really, really tired of all the social manipulations after I've gone so far out of my way to be available. It seems that I'm being ignored in every way just because I insist on communication. And yet, my father's death is another legal issue. There are many things I've been promised, including art and guns. But while my mother may still have possession of these things now, she can lose her legal rights to manage her own affairs after next year and the Jehovah's Witnesses, for whom Ivan is a Pastor, have a history of intentionally depriving me of things I've wanted, a painting, a car, and other things - and I'm accusing Ivan personally of depriving me of two different pieces of land. By ignoring me, they're trying to make me feel like I'm not worth talking to, but I just feel cheated. I didn't do anything to deserve this.

I am going to add this letter to my website at <https://skysurfer.media/small-claims/> and send a copy to the owner and management. Let's try for full disclosure. I am asking you, the police, to get a judge's order to stop the fraudulent personal water bills, provide the facility water bills on a website for all of the residents to see, and if you have evidence of any other fraud, identity theft, conspiracy, or invasions of privacy - or if he refuses a judge's orders - please arrest Ivan Erdman if you can and inform me about what's going on for a change. He's a crook, and I deserve some answers. I have asked for information regarding my status, investigations, studies, my landlord's status, and on and on, but this request has been continuously ignored and this is a very serious situation that I think demands the attention of law enforcement. If it is not in your jurisdiction, pass a copy of this along to whatever agency you see fit - but if you think this should require Adult Protective Services, please tell them this is a 55 and over park where the residents are getting poisoned before conveniently making me into a 12-60 case. I have never been so socially isolated in my entire life. I don't have any friends because 'someone' enjoys slandering me. Everything I say is exploited and used against me even in the privacy of my own home, and I get blamed if I complain. I've been condemned. Please respond.
