So, I think yesterday's appearance by my landlord was because it was also the day the water bills showed up in the mail. It's his way of flipping me off. The water submetering and the overbilling were his decisions, but he sidestepped accountability in court. The owner, Micheal Huarte, is claiming his father in southern California is actually the registered agent here, but I and other people who live here have been under the impression that the father, David Huarte, is dead and that the kids inherited this property - that's when they hired Mr. Erdman. I do not think the father was a Jehovah's Witness because the last on-premise caretaker, Dwight, had been Catholic. He died here and the property didn't have a manager for many years after that. However, the Jehovah's Witnesses do not believe in funerals and for business reasons they may believe the father is living forever in ways that are not entirely legal. That is their modus operandi, loopholes and technicalities. Meanwhile, their lawyer is requesting a jury trial which requires that the listed registered agent be served a summons, and nobody else can sign for it. Game over. After 3 years of pursuing this issue alone! I have no idea why he parked facing my front window and stared at me for half an hour yesterday besides this. He has won this battle.

Highland view knows that they're in violation of the law in many ways here. They cross the line with rent increases, late charges, and the reduction of services, too - all of which are clearly defined in the law, but since it's just Civil Law there's nothing anyone can do about it. There is no enforcement of landlord tenant laws that protect the tenants, and no lawyer wants to deal with landlord issues or small claims. They do what they can get away with. It's not a joke that there are also serious violations of privacy including eavesdropping by electronic means. I've also seen Mr. Erdman go through people's mail using a master key. I've seen him cut open the bottom of an electric meter to wire in something directly. He's short circuited people's electricity to try and damage electronics - this he told me - and he'll blow air back up through the sewer, or let air out of your tires, if he gets yelled at. There is no respect for personal boundaries at all and he exerts his authoritarianism even in the privacy of my home in any way he can get away with, even policing my social interactions on and off the property. My landlord, DHS, and the Jehovah's Witnesses have done everything they can to prohibit me from having any sexual relationships, or even any friends for as long as I've lived here in Corvallis. As crazy as it sounds, they even do what they can to keep me from playing guitar because they don't believe I should be allowed to make music - they believe it's a tool of the Devil. They don't even want people listening to music and they're militant about pushing their beliefs on others. All of this without any legal accountability. And the housing authority does not seem to care.

Meanwhile, even my internet connections are being monitored and somehow my landlord is aware of what I look up on Google? I know this sounds paranoid, and why should I care? But I know it's a matter of record that I've been framed for crimes I didn't commit. There seems to be some kind of constant investigation or psychological study that someone connected to my landlord is involved with, and I have not been able to get any answers. The problem is that these people lie, cheat, and steal in the name of God, and they're not afraid to take things out of context, misrepresent the truth, or even fabricate whatever data they need to push an agenda that's probably also illegal. The Jehovah's Witnesses are notorious for this, especially in this area, and many others have made complaints like mine. The other problem is that my landlord is paranoid. I won't go into analyzing the pathological beliefs that cause this in this email, but the result is that he's emotionless and humorless. And, he takes everything very literally. So, I can't even look up the price of black powder without it becoming a federal level investigation complete with scanning my home and vehicle for possible bombs - I think you know this actually happened, recently. Ironically, I learned that it's not illegal to actually make black powder, but I don't have any. I suspect there are probably extensive records on me from so many investigations (or studies) but I have not had access to any of them. I am regularly accused of the most nefarious things based on anything I say or do, but not given the benefit of the doubt ever. And I have been accused of many, many things.

It took a lot of years for me to figure out who was behind this attack on my character, and it was only after the death of my friend two years ago that it became apparent there was a religious agenda behind it. It should go without saying, I would never choose to be a Jehovah's Witness, either. This is well documented in all of my letters over the years. It's surely also a matter of record that I've blamed my neighbors, drug addicts in the area, and even my own mother for betraying my trust, and all I've asked for is due process and information, not loopholes and technicalities. The truth is, they have instigated problems with several different groups and that resulted in severe social isolation even prior to Covid. I am partly to blame for this, but all I can honestly be accused of is getting mad, yelling and screaming, and stomping my feet in the 'privacy' of my own home for the most part, or taking it to the river when I was homeless two decades ago. But I am still just a law abiding citizen being exploited by a criminal group.

I have taken advantage of the eavesdropping and my manager's paranoia for my own entertainment, also, and for this I can be blamed. I know he's got a fear of being blown up, for instance, so I've muttered about putting a bomb out with the trash and then watched as he got help from the fire department on garbage day. As a matter of protest, I say things randomly like, 'Tomorrow, I shall attack from the sky'... the day before he goes out to mow lawns. And I've enjoyed looking up things on the internet that only a paranoid person would worry about. Like, 'Can you train a burmese python to kill a human?' Or,

'How much electricity can a five gallon bucket of water hold?' One day I learned that if you put a flight control board on a model rocket, technically it becomes a guided missile. There's actually a YouTube video on it. Then I go back to whatever I was working on. It's good therapy. But these antics have also backfired on me. My landlord is paranoid about being poisoned, too. This is especially ironic because I've spent so many years trying to find out what chemicals are in use on the property, but instead of answering my questions they tell people I might poison their food, not to attend one of my BBQs or accept anything from me. Apparently, I make things worse when I then look up the toxicity level of poison dart frogs, followed by how to make poison-tipped darts. I think of this as humor, but I suspect my landlord does not. And I think the record should show that I'm not the one who's criminally insane. But, last week I looked up grass killer to find the mildest solution for an area I'm landscaping in my yard. Sure enough, I got undercover agents monitoring my shopping for herbicides and I got followed wherever I went that day. I know things like this are hard to prove, and people like my manager depend on plausible deniability, but I've been treated like a criminal for the majority of my adult life. I'm adept at the game. If I were a criminal, I'd be a good one. But I was taught to report.

So, here I am living in a place that's like being on house arrest for more than a decade and a half. I have PTSD from both overt and covert traumas that all stem from abuses by the Jehovah's Witnesses as far back as Kindergarten. I'm a recovered alcoholic, sober for 12 years despite their attempts to keep me from having any social support. I display a few symptoms that suggest I may have had a small stroke in the past, most notably a mild prosopagnosia which is very misunderstood because this symptom is usually extreme in much older patients, and there are a few other mild conditions that, of course, are worse when I'm tired. I also suffer from nerve damage from falling through a floor and breaking my neck. And a decade prior to that, I was drugged without my knowledge or consent, with angel dust. After that I was sick with a walking pneumonia that was likely related to H1N1 or the Bird Flu and I went septic. Since then, I have suffered from a condition that comes from a buildup of what they call 'the death antigen'. Though the benefit to such a vicious autoimmune system is that I don't get sick anymore with anything, the downside is that the aging process was triggered in me at the age of 30. I'm 52 now and I have long wondered if I would make it to 60. I'm in pain daily. Plus, I don't have any friends. I have also had trouble getting medical help here in the U.S. since I've refused mental health, but in that respect I think it should be a matter of record that I'm pretty good at taking care of myself and I'm not crazy. I show some obsessive compulsive tendencies that likely come from being given too many antibiotics as a small child, and I have a history of anxiety in many forms. I have been labeled every other kind of psycho, schitzo, delusional pathos that there is, much like the list of heinous crimes I've been accused of, all a matter of social engineering. I'm far more sentient and practical than it may appear. And I didn't do anything to deserve this.

Regarding the water bill that showed up yesterday, it's just one square of the chessboard where I was trying to force communication. I still have not received any answers to any of my other questions, either, none of them. And I don't consider Mr. Erdman's posturing to be amiable. There is nothing stopping someone from responding to me with respect - in writing, in this case, and all I have asked for is what the law requires. But I can't even get simple questions answered. Like, have I been trespassed from a coffee shop, or not? It's not that difficult to either answer the question No, or serve me with papers. But instead, I only see behind the scenes manipulations, nothing close to a respectful answer. This is how I've been treated for as long as I can remember here in Corvallis. Financially, I was awarded about what the Small Claims cases have cost me, but I cannot afford a lawyer to proceed into trial court if I could even find a lawyer, if I could even get the summons served properly. The \$3k award for which there was a lien created has been set aside and that was earmarked for the taxes I owe on this place. Losing this case just means one more year that I can't afford to travel. Pursuing this case would entail selling off assets to keep up with financial goals and I would probably still lose. It's not reasonable to expect an individual on Social Security to take on an international organization like the Jehovah's Witnesses, backed by lawyers and intelligence information. They don't believe they should have to follow the law, and if nobody enforces the law, then they won't. As a citizen, my job was over once I reported to the authorities. I think I have gone above and beyond fighting for what's right for everyone who lives here because I try not to pursue issues that are solely personal (i.e. I don't think this should happen to me, only if I don't think this should happen to anyone), but I'm dismayed at the lack of support from the local community when it's so clear that I'm not the only one being exploited and cheated.

After 3 years of trying to get information about something plainly written into the law, there is no practical legal recourse for obtaining that which should be easily available, an actual copy of the public water bill, no recourse for proving the overbilling, and no way to change it. I simply have to pay the fake bill or be evicted. Now consider that I have spent more than 10 years trying to get answers about whether I have a child. How long would that take in court? Is it even possible to force such communication, and would I live that long? Until recently, I've assumed anyone in a position of authority would be subject to the law and that they would want to uphold it. I have been through the gamut of filling out forms and making calls, and I'm sure my letters add up to tens of thousands of words. It's no secret that I've been ignored. Putting more money into a system bogged down by corruption only further empowers the corrupt, it would seem. As it is, I have been overwhelmingly disempowered socially and financially. I believe the same people are responsible for hustling a key fee, a different monetary judgement, and yet another \$100 bill from me - my landlord, Ivan Erdman, believes he should have control over whether I'm allowed to work and what I should have to pay, far beyond the water bill. I was unfairly terminated from my job with DoorDash last July and I believe that was related to my case against Highland View. That cost me thousands of dollars, as well as eliminating the plans I had for travelling last year. Now, I make less than minimum wage and I work a lot of hours to make ends meet.

I'm tired of this. I'm done. This battle has been lost, but the war is not over. I am trapped in a situation of psychological warfare perpetuated by a religious cult, and there is no escaping without abandoning my dreams. They have co-opted my family and I believe they have kept land and money from me, as well as guns from my father - and it is insulting that nobody would treat me with enough respect to even inform me. While I believe my own father is living forever in Heaven, I think the Jehovah's Witnesses are guilty of fraud. It's tempting to sell everything and just go live in Mexico, but I won't spend the rest

of my life hiding in exile just so I can have friends again - that didn't work last time, anyway. I was born and raised in Oregon, and as far as I'm concerned Ivan Erdman can take his family back to Montana if he doesn't like Oregon Law, but I suspect his choices would be unconstitutional there, too. This is the last I plan to write about this. I will include a copy of this as a final statement with the Proof of Service by Mail for the lien in Case 24SC00677 and my motion for denial to go to trial, which also proves that the Judge was lied to about David Huarte being the one who would sign for it. I will not be filing another Small Claims Case regarding the water, and there is no reason for a full jury trial when all I requested was a document to begin with. The system has failed, not me. I'm writing this for closure in this case, as a statement of my position, and to put the ball back in the court of law enforcers and the Judge. I simply have better things to do with my time, energy, and money - but I will never give up fighting for what's right, even though the system is bogged down by red tape and lies. This is also a plea to law enforcement to consider individuals when enforcing landlord tenant issues, and a plea to social services to actually respect the law. I know the problems with DHS here go beyond my personal struggle, but the answer lies in transparency not more legal games of smoke and mirrors. I've never known such a deceitful group of people, the Jehovah's Witnesses, with their own version of reality that demeans everyone else. But if the law doesn't protect individuals against such inequities, the system fails. As for me, I'll continue to take care of myself despite all adversity, and I am available for any further communication.

My landlord, Ivan Erdmann, is intimidating me. I returned home awhile ago to find him parked across from the corner of my house. He's parked out far enough into the street that he's able to watch both directions down Main St. and East St. here in the park. It is private property, and he is the property manager, but he's done this before when he wants to intercept the mail or a person - this is the position to see both entrances to the park, too. It is way too early for the mail, but it deserves noting that Ivan Erdman has reported me as a threat multiple times and insists on police protection for things like picking up the trash... and now he's literally parked facing my house, watching me as I type! This deserves reporting. Since we have ongoing legal business, and ever since he lied to me, we have an in-writing relationship. He has refused mediation and refused to take responsibility as the registered agent here in court, so there's no accountability for his violations in my life. Is this my right to go question him? Lol. He's a liar and a crook, intentionally ripping off people who qualify for government aid while avoiding taxes, or any other legal accountability; Now he's just turned around and repositioned himself in almost the exact same place, I suppose to get my attention. There is nothing stopping him from answering my emails, though. I've asked many pertinent questions, all of which I have a legal right to have answered, and he simply lies when he can't avoid being questioned. He's not here with my best interest in mind, of that I'm sure. I doubt he has any legitimate business here, even if it's not illegal to camp by my house. This is for the record, all the same. The next time he claims he needs protection because he saw me walking, or driving, you can remind him of this. He's obviously not afraid of me, just likes to intimidate and fear monger, gaslighting... Surely the police have better things to do than deal with a psychopathic slumlord, and so do I. This is for the record, anyway. I doubt there's anything you can do about him.
